Waiver Details: The venue waiver includes the rental fee of the facility. Technical fees are not included with the waiver.

PLEASE NOTE: An organization may only apply for a SoundScape Wall Use Grant once in each calendar year. An organization may only apply for a Community Benefit Fund Rent Waiver Grant once in each calendar year, for a maximum four-day run. Daily facility rental fee not to exceed \$4,000 per day. Organization is responsible for all other charges incurred with the facility. Applications will be reviewed by the Cultural Arts Council. Priority will be given to content that advances and promotes the arts. Documentaries, political messages, commercial content and/or advertising are strictly prohibited. All content must be suitable for family viewing. The highest standards of artistic production will be imposed. On-screen sponsor recognition is limited to one sentence: "Tonight's presentation is brought to you in part by (name of individual or organization)." Logos may not be included.

Feature films must meet the City's criteria for outdoor public screening, which include a rating of "G," "PG," or "PG-13" by the Motion Picture Association of America, and appropriateness of the

film to the large-screen format. All proposed films from the United States that are rated PG will be reviewed prior to giving a grant to ensure the film does not contain nudity and other elements not suitable for open, public viewing. Proposed films must be submitted to <u>at least two weeks</u> prior to screening date to ensure adequate time for staff review. The City and NWS shall consult and work together, and may look to the NWS Standards as a guide, in establishing appropriate cultural and artistic criteria and standards of quality of proposed screenings.

A Public Performance Event License for the proposed feature must be provided to the City prior to the screening.

Up to ten SoundScape Wall Use Grants may be awarded annually based on availability. Use of the wall by New World Symphony and/or City of Miami Beach has priority over any and all third party users.

The SoundScape Wall Use Grant does not cover the costs of required technical staff, which must be supplied by or approved by the New World Symphony; nor does it include the costs of City services that your event may require.

Approved applicants must also obtain a Special Event Permit for use of SoundScape by visiting
